# General Permit Conditions

A copy of the permit and the approved route map **MUST** be in each vehicle listed on the permit when in use.

Wood County Sheriff's Department will be informed of all permitted haulers. If a driver is stopped and is not carrying a copy of the permit and map, or is found to be operating off the approved route, the Sheriff's Department may cite the operator.

Application form shall be filled out completely. Leaving any information blank may result in the denial of the permit. Fees not paid with application submittal may delay the approval of the permit.

The Commissioner has the right to deny or suspend a permit if road conditions are too severe to allow loads greater than the seasonal posting on desired county highways.

The permit is not valid unless signed by the Wood County Highway Commissioner or a designated representative. Any attempt to receive a verbal permit is not allowed.

# Special Permit Conditions

Please check which listed essential service this permit covers.

- Raw Milk Hauler  
Must have map(s) of approved route(s). Route(s) may be altered by Commissioner. May run loads at full approved weight rating.
- Waste Disposal  
Must have map(s) of approved route(s), if required by Commissioner. May run loads at full approved weight rating. Roll-off dumpsters not included under this permit.
- Septic Hauler  
No route map required. Allowed to enter county highway legally, visit one residence or commercial property, and take shortest route back to a non-posted road.
