MINUTES OF THE JUDICIAL AND LEGISLATIVE COMMITTEE

- 1. At 9:00 a.m., Chairman Clendenning called the meeting to order.
- 2. Public comments. None.
- 3. The minutes for the December 7 and 18, 2018, meetings were reviewed. Moved by Hamilton, seconded by Leichtnam, to approve the minutes. All ayes.
- 4. The Committee reviewed monthly voucher and department reports of the departments it oversees. Moved by Hamilton, seconded by Curry, to approve the reports and payment of department vouchers. All ayes.
- 5. The Committee reviewed the claims of the estate of Trequelle Tyreke Vann-Marcouex and the ERD case of Anne La Chapelle. These claims will be provided to the county board.
- 6. There were no new animal claims against the County.
- 7. The Committee reviewed correspondence and legislative issues.
 - a. Creating a rule for certain vacated constitutional offices. Moved by Leichtnam, seconded by Hahn, to approve the procedure prepared by McGrath for a mechanism to fill the vacancies of constitutional offices. 3 ayes, 2 nays. The nays felt there was no hurry on proceeding.

Moved by Hamilton, seconded by Curry, to authorize per diem and mileage for Hahn's attendance at a meeting with Human Resources regarding this topic. All ayes.

b. Central Sands Water Committee report. Citizens Groundwater Group (CGG) is the new name to this entity. The CGG has invited the County Board Chair to attend future meetings. Representative Shankland shared with the CGG what other counties were doing and Supervisor Leichtnam encouraged Wood County to do more. Leichtnam reported that Minnesota has a ½-cent sales tax that is allocated to water quantity and quality. CGG wants legal advice as to what counties can legally do to support water quality and quantity issues.

c. April ballot referendum on medical and recreational marijuana. Discussion had on the pros and cons of recreational marijuana. Impacts insofar as a gateway drug and tax benefits. Moved by Hahn, seconded by Curry, for a referendum for medicinal and recreational marijuana. 4 ayes, 1 nay. Clendenning opposes as he sees it as a gateway drug.

The Committee expressed concern that the County doesn't have an ordinance prohibiting possession of marijuana like the cities in the county do, thus forcing use of criminal procedures. Clendenning will bring this to the attention of the Public Safety Committee to address.

- d. Marathon County resolution on increased compensation for defense counsel assigned by public defender. Wood County has previously acted on this and supported increasing the public defender rate as it does impact the county. The WCA is addressing the issue and has identified raising the rate from \$40 to \$70 per hour as a legislative priority.
- e. Door County resolution supporting taking steps to legalize medical marijuana. Addressed above.
- f. Door County resolution supporting legislation authorizing utilization of Design-Build. Last year Wood County approved a resolution supporting changes to the laws on this. No further action sought by the committee at this juncture.
- 8. Courthouse security committee report. Maintenance Supervisor Van Tassel discussed increased security steps being taken in 2019. It is likely a metal detector will be installed and available for use at the front door of the courthouse in several months. There are no funds designated to staff the equipment at this time. Van Tassel was encouraged to proceed on safety measures that have been budgeted and report back to this Committee on them.
- 9. Discuss recommendation to appoint a Criminal Justice Task Force Coordinator. The Task Force wants to know if this committee will support a Task Force Coordinator. Moved by Hamilton, seconded by Hahn, to support the concept of creating a full-time Task Force Coordinator position at county expense. 3 ayes, 2 nays. The nays (Curry and Clendenning) are simply looking for more details before committing to this.

10. County Board rules.

- a. Reformulation of Executive Committee. Clendenning proposed that the Executive Committee consist of the county board chair, first and second vice chairs, and two members voted for at large. Other committees would be selected by the Executive Committee. All committees would elect their own chairs, including Executive. The Executive Committee would then select the County Administrative Coordinator. This proposal and other related ideas will be discussed next month.
- b. Formation of a stand-alone Economic Development Committee. Supervisor Hahn wants to see the county do more in terms of promoting economic development and presenting a clearer vision. Supervisor Curry, as the Chair of CEED, has planned and will be holding a separate meeting of CEED to focus on economic development. Planning & Zoning Director Jason Grueneberg advised he supports a higher level of attention being given to economic development at the committee level. Supervisor Clendenning supports local (city, village, town) economic development, not necessarily having the county involved. Supervisor Fischer talked in terms of the county identifying its objectives in economic development and then responding to those goals in dealing with our partners.
- c. Census Review & Redistricting. Jason Grueneberg advised that the county has a Census Review & Redistricting Committee, which has as its main focus the establishment of supervisory districts after the decennial census. The Census Committee does not report to CEED. The Census Committee does have to comply with state and federal standards, which are rather comprehensive. During the approximate 8 of every 10 years the Census Committee isn't needed and doesn't exist, the limited duties are dealt with by CEED as the oversight committee of Planning & Zoning.
- d. Public Property Committee. Chairman Clendenning advises the County Board wanted further study on this matter, so he proposes, with no objection by the Committee, to appoint a subcommittee to study the matter. The members would be two from Judicial (Curry and Leichtnam), and one member each from Health & Human Services, HIRC, and Public Safety Committees; each of these committees would appoint their one member to the subcommittee.
- 11. Agenda items for the February 2019 meeting:
 - Reformation of Executive Committee and appointment of other committees.
 - Countywide ordinance prohibiting marijuana.
 - Criminal Justice Task Force Coordinator.

- 12. The next committee meeting will be February 1, 2019, at 9 $\mathrm{a.m.}$
- 13. Meeting adjourned without objection by the Chairperson at 11:20 a.m.

MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE

Prepared by Child Support Director Brent Vruwink

- Supervisor Clendenning, Supervisor Fischer, Veterans Services Officer Rock Larson, IT Director Amy Kaup, Human Services Director Brandon Vruwink and I attended WCA CAP Day on January 16th. I was able to meet with nine different legislators about legislative issues concerning child support. I have attached the legislative issues that the Wisconsin Child Support Enforcement Association (WCSEA) is working on. The meetings were the first of many that I will be involved with over the coming months as we work to secure increased state funding for the child support program. I wish to express my gratitude to Supervisors Clendenning and Fischer for their involvement in the meetings. County Board Supervisor involvement is key to our success when working with state legislators.
- A child support liaison from Forward Service Corporation will be meeting with agency staff on February 7th about different programs and services they offer to help our customers gain employment.
- I will be attending WCSEA meetings on February 14th and 15th.
- I will be attending the department head meeting on February 20th.
- Wood County's Children First Plan was approved. We were awarded the 60 slots that we requested. Wood County is one of 20 Counties that have a Children First Program.
- The cooperative agreements have been signed by all departments and have been submitted to the state for review.
- I reviewed the December Performance Numbers. The numbers remain strong and we are on pace to have another solid year.
- The current IV-D case count is 3,895.

The Wisconsin Child Support Enforcement Association (WCSEA) is a statewide association representing child support agencies throughout Wisconsin. Our mission is to help children and families by establishing and maximizing the collection of child support. In addition to providing economic security to children, child support agencies work to support the involvement of both parents in their child's life and connect parents in need to job services.

Increase County Child Support Funding: An additional \$1.5 million of state funding per year is needed to help local agencies meet increased demands from e-filing, current caseloads, new federal regulations and to ensure that Wisconsin can continue to be a national leader in child support collections. Increased state funds would draw down a federal match of roughly \$3 million each year. For every \$1 invested in the program, Wisconsin's child support agencies collect \$5.56 in support. Child support agencies also help save state taxpayer dollars by establishing health insurance orders for 97% of cases, which reduces state Medicaid costs by moving children from BadgerCare to private insurance. Wisconsin's strong performance in child support is at risk without additional state funding, which could lead to a loss in federal funding.

Establish an Administrative Paternity Option in Wisconsin: WCSEA supports the creation of administrative paternity in Wisconsin. Administrative paternity is a new, optional way to establish paternity outside of the court system based on the results of a genetic test. This proposal benefits both children and parents by legally establishing fathers' relationships with their children more quickly than can be done through the court process. In requiring a positive genetic test before paternity is established administratively, the proposal assures the family that the determination is accurate. The proposal frees courts from having to address uncontested paternity cases, allowing more time for cases that require the assistance of the court to resolve paternity, custody and placement questions. A father will still be able to have a court hearing on the issue of paternity if he contests the genetic test results obtained through the administrative process.

MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE January 2019

- Reichert v. Wood County. Former Sheriff Reichert has sued the County alleging he has a right to 1. Post Employment Health Plan (PEHP) benefits. Human Resources has long felt that PEHP benefits only apply to employees who receive sick leave benefits; elected officials don't, and that sick leave benefits are not somehow retained by an employee who runs for elected office absent some sort of resolution authorizing a leave of absence or a labor agreement. This office is handling the case on the County's behalf as retaining counsel, either directly or through an insurer, would cost the county \$300 - \$500 per hour. Reichert's primary argument is that the resolution authorizing his compensation for his last term of office provided that he receives the same retirement benefits as the non-elected department heads. The County's position is that the PEHP benefit is not a retirement benefit; instead, it is a sick leave benefit as it is a part of a program that was established to control the abuse of sick leave. The complaint has been answered and if you want a copy of it or want it to go in the packet to the county board, please advise. At this point, I am nailing down all of the relevant facts and after doing so and any discovery has been completed, I will consider preparing a motion for summary judgment (SJ). SJ motions are presented when there are no material issues of fact and the stipulated facts and applicable law obviate the need for a trial. A relatively small percentage of SJ motions are granted but they help limit the scope of the case that then needs to be tried. The case has been assigned to Portage County Circuit Court Judge Robert Shannon. I will keep you posted as the case progresses.
- 2. Nitrate contaminated water. Over 80 property owners in the town of Port Edwards and the Juneau County town of Armenia have filed a complaint against Central Sands Dairy and Wysocki Produce Farms, Inc., alleging the defendants have and continue to pollute the groundwater of the plaintiffs and the plaintiffs are seeking monetary and injunctive relief. The complaint mentions the MOU that Wood and Juneau Counties may/have entered into with the Armenia Growers Coalition (AGC), which coalition the defendants are members of and alleges it is inadequate to address the losses suffered by and likely to be incurred by the plaintiffs. The litigation was anticipated by the counties and was seen as a driving force behind the AGC's desire to provide some level of redress to the owners of properties within the impacted agricultural corridor. On a related note, Juneau County approved executing the MOU with the AGC at its January county board meeting.
- 3. <u>Duerr Appeal.</u> Former Human Services Department manager Kristi Duerr has exercised her right to use the Complaint Resolution Process (CRP) to appeal her termination of employment from the County. The next step to the appeal is a type of hearing conducted by the county board. This is essentially a paper review with each side being given the opportunity for a five minute oral presentation to the board. This will be held in conjunction with the February county board meeting. It is imperative to read all of the information that comes in the county board packet pertaining to the appeal for you to be prepared for the hearing. My role is to assist the board and the Chairman procedurally. I am not an advocate in this matter. Ergo, it is unlikely there will be anything for me to say during your deliberations. Feel free to present me with any procedural questions you have. The supervisors are not to discuss the case in any way with either Ms. Duerr, her counsel, Patrick Arendt, or the County's representative on the case, Kim McGrath, or any fact witnesses.
- 4. Sundry Matters. Joan Arnold has not appealed the independent hearing officer's decision so that should end that matter. Things are settling in with the legal secretary duties in the office. Erin is doing a great job and keeps learning. No increase in her ½ time hours is foreseen at this time. I have changed Lisa's job description to make her the Lead Legal Administrative Assistant. Additional duties include workflow management and coaching/mentoring. It is technically a new position. The 2018 budget came out almost exactly with \$25.44 left over.

NARRATIVE:

Initial Report

On December 21, 2018 at around 8:07 p.m. I was dispatched to 8628 County Road K in the Town of Arpin, Wood County, Wisconsin. Dispatch advised a complainant had called to say that earlier in the day a Wood County ditch mower had struck his cow and the cow had now bled to death.

I asked dispatch if there was any report of this earlier in the day. Dispatch advised there was not.

Arrival on Scene

Prior to arriving on scene I observed two subjects in the ditch to the north of the residence. I stopped and the subjects advised they were the complainants for the deceased bull.

I arrived on location and the complaint, identified to me as Logan Sankey, advised me his bull was deceased after he believed it had been struck by a Wood County ditch mower. Logan informed me he had been gone at work all day but his wife Elizabeth Sankey had sent him a picture via phone saying their bull was deceased and that a Wood County ditch mower had been out in the ditch earlier in the day and they believed the mower had struck the bull.

Logan and Elizabeth then took me back to where the bull was located at my request. The bull was lying to the east of the barn on the property and it was obviously deceased. The bull was lying on its right side and its fur was caked in mud. I observed a large amount of dried blood around the bull. Logan showed me where the bull's right horn was cut off approximately four inches above its head. The horns on the bull were very short and I did not observe any other trauma to the bulls head. The cut location was very clean and smooth. I did observe there was a small amount of red blood coming from the horn. I attempted to inspect the bull visually and did not see any other signs of trauma to it on its left side. I asked to see the right side of the bull and Logan attempted to do so but the bull was too heavy for him to move. Rigor mortis had either not yet set into the bull or was already gone.

Logan believed that when the arm on the tractor mower was picked up the bull also picked up its head and the mower hit it.

Elizabeth then began saying that she was in the living room and she saw the ditch mower go by and he picked up the mower deck to go around their mailbox. Elizabeth then said the mower continued for a bit and then stopped and idled for around 10 seconds.

Logan further informed me that he agreed with me that someone had not intentionally cut the horn off the bull. Logan also mentioned that the Wood County Highway Department has insurance for a reason after I told him if he believed they cut the horn off the bull then he should contact them.

I next informed Logan that if he was to contact Wood County Highway he should attempt to photograph the entire bull. Logan then said he planned to skin and butcher it immediately, but would keep the head.

I asked Elizabeth when the last time she had seen the bull alive was. One of the children said it was around 4:30 p.m. but Elizabeth said she was wrong and it was a different cow. I asked Elizabeth what time the mower had some through. Elizabeth told me it was around 10:30 a.m. Elizabeth then said the cow bled out slowly from the horn. I mentioned that I was shocked there was no other blood elsewhere. Elizabeth told me the other cows lick up the blood. Elizabeth further added that she had fed and watered the bull at around 9:30 a.m. on the same date and at that time the bull was fine.

I asked Elizabeth what time she had observed the bull to still be alive. Elizabeth told me around 6:00 p.m. the bull was still alive but it was lying on the ground. Elizabeth told me she had then left to pick her kids up. Elizabeth then told Deputy Dorshorst, who arrived on scene, that she had come home around 6:00 p.m. and noticed the bull. Elizabeth said that there was a big blood clot by the bull but she believed a German Shepherd had eaten it prior to my arrival.

I then asked if they thought anybody else had cut the horn off. Both Logan and Elizabeth said "no". I asked if the bull would just allow someone or anything to cut his horn off. They both said no, but did add that the bull is friendly.

Logan again told me he believed that the mower had lifted up the deck and the bull lifted up its head at the same time and that's when the mower cut off the horn. Elizabeth added that she has seen the mower knock down their mailbox numerous times.

I advised Logan and Elizabeth to contact the Wood County Highway Department and advised them of what they believed happen.

Observations of Ditch Line

Deputy Dorshorst and I next went to check the ditch line where the mower allegedly was. I checked the ditch line and there was only undisturbed snow and grass. The only thing I did observe that was cut was a very small cluster of scrub brush. The brush was not cleanly cut and appeared to have been possibly twisted off. There were no other tracks or signs of anything mowing the grass. I walked the ditch line and was unable to locate anything that would be consistent with anything being in the ditch cutting.

I further observed that the four strand barbwire fence was undisturbed. I did not locate any blood or the missing part of the horn where Elizabeth alleged the mower had been. Further, Elizabeth had come out to where Deputy Dorshorst and I were. Elizabeth was insistent that the grass in the ditch had been cut. All of the grass that I observed was dead. There were no clippings or trimmings indicating anything had been cut. Elizabeth then informed me the mower had cut the west side of the road ditch grass. Deputy Dorshorst and I checked the ditch line and again only observed dead, uncut grass.

Conclusion

I was unable to contact Wood County Highway to find out if a mower was out in the ditch or not due to it being past normal business hours.
