# MINUTES OF THE HIGHWAY, INFRASTRUCTURE & RECREATION COMMITTEE

OTHERS PRESENT: Sandra Green, Wood County Parks & Forestry Office Supervisor/ATV Trail Coordinator; Chad Schooley, Wood County Parks & Forestry Director; Supervisor Dennis Polach; Shawn Becker, Wood County Sheriff; Roland Hawk, Highway Dept. Commissioner; County Board Chairman Lance Pliml; Fritz Schubert, Wood County Forest Administrator; Supervisor Bill Clendenning.

- 1. Call meeting to order. Meeting was called to order at 9:00 am by Chairman Hahn
- 2. Declaration of quorum. Declared.
- 3. Public comments. None.
- 4. Correspondence. R. Hawk mentioned that a vendor who builds shop & repair trucks with a truck mounted crane and specialty components has provided information to the Highway Department for the specific purposes requested by the Hwy. shop. He is seeking permission to negotiate directly instead of requesting bids. The vendor only builds shop trucks and is very skilled at providing exactly what the owner needs. They would create what the Hwy. Department requests and there would be a good ROI. The chassis would be obtained through a dealer at a competitive rate; the exterior is stainless steel or a composite material and would be able to pull a trailer. The committee would need to see a cost and benefit analysis. Commissioner is proposing to solicit bids or enter into a contract in September and have final billing in 2022.
  - C. Schooley wanted to let the committee know that the WR CVB, Visit Marshfield, MACCI, and HOW are funding an outdoor recreation promotional video. Some of the filming will be done right in our own parks system including South Park, the ATV Area and possibly Nepco.
- 5. Approve minutes from previous committee meetings. Motion by Supervisor LaFontaine and second by Supervisor Breu. Motion carried.
- 6. ATV Trail/Route system update: R. Hawk provided an update as they have been getting many phone calls along with the Parks Dept. on what is open/closed, etc. The best way to deal with this is to open all county roads in townships that permit ATV/UTVs on their roadways, and sign the highways that are not open. R. Hawk developed a list of county highways that are not safe for ATV/UTVs and created a map showing the routes in the county that should not be open to ATV traffic. He used existing traffic volumes, highway classification, crash data, and highway cross-sections to identify the routes that are not safe for ATV/UTVs. Sheriff Becker agreed with the method and the list of roads R Hawk proposes to keep closed to ATV access.

There are two options to signing the county highways, one is to continue signing all routes that are open, and the second would be to pass an ordinance that all county highways are open except where otherwise indicated. The Highway Department prefers the latter, which reduces the number of signs that need to be maintained.

R. Hawk also is requesting two changes to the ALL-TERRAIN VEHICLE ordinance. Hwy. Dept. has received complaints about ATV riders impeding the flow of traffic in certain parts of Wood County because ATVs are limited to 35 mph on the highway.

- a. Allow ATV traffic to travel the posted speed limit to move smoothly with traffic.
- b. Require that all ATV riders who operate on designated routes carry liability insurance.

The ordinance changes would take affect as soon as the Wood County Board of Supervisors passes them. The route changes would take affect when the grant money is awarded, which may be no later than the end of 2022. Motion by Chairman Hahn and second by Supervisor Hokamp to open all county roads/highways as noted above. Supervisor Breu – no, because he has been against ATV's on roads from the beginning and feels it is just not safe for anyone. There is not enough enforcement, they are a liability and not built to operate on roads. Motion carried.

Motion to adopt an ordinance that would allow ATV's to run at the same speed as the posted speed limit by Supervisor LaFontaine and second by L. Thao. Supervisor Breu – no because they are unsafe and generally opposed to running on the roads. Motion carried.

Discussion: There are quite a few ordinances that are currently stated to be 35 mph in the townships, cities and villages. We need to work with the Towns for consistency. Supervisor LaFontaine has concerns on safety. Has there been a study done on this with the DNR? Sheriff Becker stated that this information may be found on the DNR's website perhaps in their Annual Report (Recreation / Safety, etc.).

The request by the HIRC is to have an ordinance created for the next County Board meeting. Schedule a short meeting prior to for HIRC approval.

Supervisor Breu wanted to express that he has concerns regarding ATV's on roads. He read an article that stated 50% of fatalities have occurred on highways. In addition, there is a sticker placed on the ATV when it is sold that says, "Not for highway use".

Supervisor Clendenning asked why an economic development study has never been done in Wood County regarding ATV's. Supervisor Hahn stated that he thought that was in the process to begin this fall or early spring of 2022.

#### 7. HIGHWAY

- a. Highway staff reports.
- b. Highway revenue report
- c. Highway vouchers. Motion by Supervisor Breu and second by Supervisor LaFontaine to approve highway vouchers. Motion carried.
- d. Request for hire Truck Operator. R. Hawk said one of his truck operator retired and moved onto another job. He is requesting to hire a replacement. They have a list of names and will interview. **Motion by Supervisor Hokamp and second by Supervisor Thao. Motion carried.**
- e. Salt Storage Building Foundations Bids. **Motion by Supervisor LaFontaine and second by Supervisor Breu to go with the bid that is most advantageous to Wood County. Motion carried.**
- f. Surplus Lands. R. Hawk stated they sold a right-of-way and have another 12 acres they are considering selling.
- g. Attenuator Reimbursement. The DOT agreed to reimburse the Hwy. Dept. for the cost of the attenuator purchased earlier this year and has agreed to provide funds to purchase a second attenuator later in 2021.
- h. Marshfield Campus study update. Sheriff Becker and R. Hawk gave an update regarding the Marshfield Campus Study, which looks at the feasibility of moving the City of Marshfield Public Works and Street Department to the WCH Marshfield site on Galvin Avenue, along with providing shared space for the Highway Department and room for the Sheriff's deputies and staff

who currently work out of the Norwood facility. The Study costs \$28K and WCH is responsible for approximately 30% of the study costs. Moving the Sheriff Deputies to the Galvin Avenue location improves safety for those officers who are responding to a call south of the city. The location is adjacent to Hwy 13 and US 10 which allows for faster and safer responses. The study should take 3-4 months to complete. It was discussed if they should also look in to adding a "holding area" as part of the study.

i. Survey equipment updates. The current equipment the Hwy. Dept. is using is no longer supported by the company and is not working properly. They are requesting to move to Leica equipment. This cost would be approximately \$21k. Hwy is also discussing the options of installing base stations within the county, possible locations include Powers Bluff. These have a 15-mile radius, so they are hoping to place these centrally in Wood County. The cost to put in the base stations would be about \$10k, however, the vendor may offer a discount to install if available to the public. The surplus value on the old GPS/Survey equipment is estimated \$10K-\$12K.

#### 8. PARKS AND FORESTRY

- a. Parks & Forestry staff reports
  - C. Schooley brought up that there has been an increase in security and vandalism issues out at South Wood County Park, as well as the rest of our parks properties. He is looking into options for security cameras through Solarus. Solarus currently has public Wi-Fi availability at South Wood County Park, and we would be able to use this for our security cameras. The cost to purchase and install cameras at the Red Sands Beach pavilion, South Park ranger station, White Sands Beach shelter, and the Nepco Lake shelter building, would be less than \$15,000. The entire HIRC urges C. Schooley to move forward with this project and find funding as soon as possible. It is an affordable project and needs to be completed as soon as possible. The HIRC also urges the Operations Committee to move forward with funding approval. In addition, C. Schooley is concerned about the lack of LTE maintenance worker applications that we received this year. Out of a total of 7 positions, there are 3 open at this time. The wage is a hindrance to a good number of applicants. Currently, the pay range is \$11 - \$13/hr. The Hwy. Dept. stated their LTE's start at \$14/hr. C. Schooley will begin looking at comparisons in the area and may be requesting a pay raise soon. These positions are not included in the County's wage table. Also, check into the possibility of lowering the required minimum age of 18.
- b. Special Use Permits. Request from Jeremiah's Crossing to have their annual fundraiser at Dexter County Park. **Motion by Supervisor LaFontaine and second by Supervisor Breu. Motion carried.**
- c. Property and Information Technology Committee inquiry to consider sale of 2.5-acre parcel in South Wood County Park. C. Schooley states that this parcel in question is a part of the original park boundaries, which was purchased many years ago using state/federal grant funds. C. Schooley, as well as the HIRC, are not in favor of selling this dedicated property. Motion by Supervisor LaFontaine and second by Supervisor Lee to respond to the PIT committee that the 2.5-acre property is not for sale. Motion carried.
- d. Future requests of selling dedicated park properties. C. Schooley and the HIRC agree that dedicated park properties should not be for sale.
- e. 2020 Parks & Forestry Annual Report. It was requested that the names of all seasonal employees be listed. S Green will be making that change. C. Schooley will be presenting the Annual Report at the July county board meeting. C. Schooley also praised S. Green and F. Schubert for their work on the Annual Report. Three HIRC members would like a hard copy of the report.
- f. P&F Reservation software purchase. C. Schooley provided additional information, and recommends purchasing the software system from Konect. Konect is based out of Green Bay, and serves several WI Counties. This decision was made with consultation and assistance from

- Chris M, IT. C. Schooley stated that the upfront cost will be approximately \$24,000, and annual maintenance fees would be \$1,600. The funds would come from the P&F Capital Projects non-lapsing account. These funds are available to use, and it is recommended that we move forward with the purchase. **Motion by Supervisor LaFontaine and second by Supervisor Breu to move forward. Motion carried.** Because there were expenses budgeted within the account that will not be spent in 2021, and because this expense will not exceed that budgeted expenses, C. Schooley does not believe a resolution would be needed. He will confirm with Finance.
- g. Wood County Forest 15-year plan Draft Chapter 2000. No changes or questions from HIRC. S. Green will place this Chapter online.
- h. Parks & Forestry revenue reports. No questions.
- i. Parks & Forestry vouchers. **Motion by Supervisor Hokamp and second by Supervisor Thao. Motion carried.**
- 9. Future Agenda Items. C. Schooley asked if HIRC would like to continue with our annual Parks, Forestry, and Highway tour this year. The HIRC stated they do. Staff will come up with date and location options for HIRC to consider.
  - R. Hawk wanted to let HIRC know that they applied for a \$384k transportation grant from the Ho-Chunk Nation and it was approved for 2024.

#### **Department Activities**

#### **Personnel**

New truck operator accepted position and will start August 16, 2021. Mechanic resigned effective July 29, 2021. Advertisement for new mechanic was posted July 19, 2021. Interviews will be scheduled early August. Seeking permission to fill. *Agenda item*.

#### Highway/Facility Projects

CTH BB (US 10 – CTH B) paving was completed July 28. The roadway will be opened as soon as shoulders and pavement marking are completed. Estimated completion data is August 12, 2021.

Work on CTH N bridges (2) (CTH F – CTH S) started June 15. The contractor has completed the east bridge and is anticipated to complete the second (west) bridge by August 27. County crews will begin pavement work August 23 with anticipated completion September 17.

Work at the Marshfield site to construct a State & a County salt shed has started. The contractor is expected to complete the foundation for the State shed August 13 and begin work on the County shed foundation immediately after. Work is progressing as anticipated.

Highway & Sheriff Department staff met with the Architect conducting the shared campus study at the Marshfield facility along with City of Marshfield representatives. A second meeting is scheduled August 17.

Commissioner held a Traffic Safety Subcommittee meeting on July 14 to initiate a WisDOT Predictive Analysis Project with local officials and law enforcement. The project is funded by a grant through WisDOT. Wood County is one of 12 counties to receive this grant for a Traffic Safety Project.

Commissioner and engineering staff met with consultant and CWPCo July 14 to gather facts about the CTH U corridor through the Village of Biron and along the Wisconsin River embankment between South Biron Drive and Huffman Road.

Commissioner attended combined WisDOT - WCHA Executive Committee meeting July 12, WCHA BOD meeting July 27, and the WCA Transportation and Public Works Steering Committee July 28, 2021.

#### Highway Maintenance

Crews have completed all chip seal projects and will be assisting contractors the weeks of August 2 and August 9 with GSB 88 applications.

Crews have been replacing failing culverts on various roadways.

Engineering staff continue to work with USACOE on the sale of land located on CTH Y (Adler Street) on the north side of the City of Marshfield was a mitigation site and has numerous deed restrictions.

Crews have been mowing State & County ditches and completed the first cut by July 15. Some areas with vision issues will be cut a second time in July & August. Some urban areas on the State Highways will be moved and maintained shorter than rural areas.

#### ATV Plan/Development

Commissioner has had several communications with ATV/UTV clubs and riders regarding the Ordinance change and when county highways will be opened. One club in Auburndale is offering to assist with providing either signs or funds to purchase and install signs. Commissioner will continue to follow up with the club.

#### **Engineering Equipment**

Final cost for new survey equipment purchased through Leica is \$24,928. The Highway Department received a 20% discount and has the funds available in 2021 to purchase for construction staking and topo surveying. Commissioner is negotiating with the vender on purchase of a base station that would be installed on the Highway building in Wisconsin Rapids and will provide wide-ranging use without having to use an added cell phone and service to connect with WisCore. The current survey equipment is outdated and unreliable for our accuracy and will be sold on Surplus.

#### **Shop Equipment**

The five year CIP equipment list includes a shop truck to be purchased in 2021 estimated at \$150,000. The shop currently has a 1996 Chevrolet pickup with an air compressor and a 2005 1-ton with a welder to use for in the field and road side repairs. The shop supervisor has researched and interviewed manufactures of service trucks that are fully equipped to make repairs in the field or roadside. Stellar Truck & Trailer located in Mason City, Iowa provided the highest quality and best options as specified by the shop supervisor. The options and price are comparable to a recently bid service truck in Portage County.

Through his investigation the shop supervisor was able to negotiate upgrades and better quality materials that best suited the needs of mechanics who will be responding to breakdowns and service calls.

This vehicle will reduce downtime for field repairs by 1/3. Average time to make repairs with trips back and forth to the shop is 3 hours. This truck will be fully equipped with hydraulic hoses, fittings, and ability cut and crimp hose fittings at the repair site. It will be equipped with bulk fluids to refill reservoirs on the truck. A crane will eliminate the need to tow most vehicles back to the shop to be repaired. *Agenda Item*.

#### **Accounting Supervisor Report**

#### Revenues

Revenues are as anticipated. We received the second of three General Transportation Aids payments in early July. We have started up the asphalt plant so asphalt revenues have started to come in. Also, the increased trucking due to construction projects has resulted in higher machinery fund revenues, shown as an offset to expenses in Fund 53240. Local municipal revenues are traditionally low at this time of year while we focus on state and county work.

#### **Expenses**

Expenses are as anticipated.

#### Other

I will begin work on the budget when Questica is available to us. I am working with Finance on the Position Allocation spreadsheet as a preliminary document utilized for budget preparation.

#### Glossary

**Agreement** - An agreement is a written document executed by two or more persons or entities expressing a mutual and common purpose.

**Best Management Practices (BMPs)** -A practice (or combination of practices) that is determined to provide the most effective, environmentally sound and economically feasible means of managing an activity and mitigating its impacts.

**Bog** - A poorly drained usually acid area rich in plant residues, frequently surrounding a body of open water, and having characteristic flora such as sedges and sphagnum.

**Biodiversity** - The variety and abundance of species, their genetic composition, and the natural communities, ecosystems, and landscapes in which they occur. Biodiversity encompasses the ecological structure, function, and processes that occur in ecosystems to sustain the system as viable entities.

**Blocking Boundary** - boundaries established for the purpose of distinguishing between lands that are best suited for forestry and fit well in relation to existing County Forest Lands, versus lands that are best suited for agricultural production and do not fit well in relation to existing County Forest Lands.

**Clearcutting or Regeneration cut** - A silvicultural system in which all merchantable trees are harvested within a specified area in one operation to create an even-aged stand.

**Committee** - Refers to the Highway, Infrastructure, and Recreation Committee (HIRC) of the Wood County Board of Supervisors. The Committee is the supervising authority for the Wood County Forest.

**Compartment reconnaissance (Recon)** - A tool where basic resource information is collected and stored, and systematically and continuously updated. The information is utilized as a tool in the assessment of geographical structural, and composition attributes of the land resource. The database is used to analyze existing resources, evaluate management alternatives, and assist in the development and implementation of the management plans.

**Cover type** - An area of land characterized by the predominance of one or more key species, which make up a dominant percentage of the area.

**Community** - An assemblage of species living together in a particular area, time, and habitat.

**Cull** - Any tree which has less than 50 percent merchantable volume.

**Cultural Cutting, Cultural Activity** - The manipulation of vegetation to meet objectives of controlling stand composition or structure, such as site improvement, forest tree improvement, increased regeneration, increased growth, or measures to control insects and disease.

**Den tree** - A standing tree, live or dead, with one or more cavities suitable for use by wildlife for shelter, nesting, or the rearing of young.

**DNR** - Wisconsin Department of Natural Resources.

**Easements** - A right that entitles the casement owner the use of the land of another for a special purpose not inconsistent with the general property rights of the owner.

**Ecological Landscapes** - Distinguished land areas different from one another in ecological characteristics. A combination of physical and biological factors, including climate, geology, topography, soils, water and vegetation, are used in the distinguishing.

**Ecosystem** -A spatially explicit, relatively homogeneous unit of the earth that includes all interacting organisms and components of the abiotic environment within its boundaries note: an ecosystem can be of any size, e.g. a log, pond, field, forest, or the earth's biosphere.

**Ecosystem management** - Management guided by explicit goals, executed by policies, protocols, and practices, and made adaptable by monitoring and research based on the best understanding of ecological interactions and processes necessity to sustain ecosystem composition, structure, and function over the long term.

**Fen** - A highly restricted type of wet prairie that supports an unusually specialized flora. It forms on wet to moist and often peaty, calcareous soils that have developed over a diffuse groundwater discharge area that is often under artesian pressure.

**Forest compartment** - A subdivision of a forest property with easily defined boundaries such as rivers, lakes, and roads. Compartments are established for forest management purposes, most notably forest reconnaissance. They may vary in size from a hundred acres to more than a thousand.

**Forest Fragmentation, Habitat Fragmentation** - The process by which a landscape is broken into small islands of forest within a mosaic of other forms of land use or ownership.

Forest habitat classification system - The habitat type system is a natural classification system for forest communities and the sites on which they develop. It utilizes systematic interpretation of total flora of a site with emphasis on understory species. A habitat type, as a basic classification unit, is characterized by a distinct combination of species (association) that reflects the ecological sum of the environmental factors operating upon that site. All sites that support (or are capable of supporting) a particular plant association, regardless of how physically different they may appear, are considered to be equivalent and represent the same habitat type.

**Forest Reconnaissance (Recon)** - A tool where basic resource information is collected and stored, and systematically and continuously updated. The information is utilized as a tool in the assessment of geographical, structural, and compositional attributes of the land resource. The

database is used to analyze existing resources, evaluate management alternatives, and assist in the development and implementation of the management plans.

**Geographic information system (GIS)** - An organized collection of computer hardware, software, geographic and descriptive data, personnel knowledge, and procedures designed to efficiently capture, store, update, manipulate, analyze, report, and display the forms of geographically referenced information and descriptive information.

**Global Positioning System (GPS)** - A system of electronic surveying technology utilizing satellites to determine location on the earth.

**Habitat** - The place, natural or otherwise, (including climate, food, cover, and water) where an animal, plant, or population naturally or normally lives and develops.

**Hydrophytic** - Plants that grow partially or wholly in water or in soils too waterlogged for other plants to survive.

**Integrated Resource Management** - The simultaneous consideration of ecological, physical economic, and social impacts of lands, waters, and resources in developing and implementing multiple-use, sustained-yield management.

**Integrated Pest Management (IPM)** - The maintenance of destructive agents, including insects, at tolerable levels, by the planned use of a variety of preventive, suppressive, or regulatory tactics and strategies that are ecologically and economically efficient and socially acceptable.

**Irrevocable Letter of Credit** - An irrevocable engagement by a bank, at the request of a customer, that the issuer will honor drafts or other demands for payment.

**Lease** - A lease is a written document, which grants use of real property and/or improvements to another party for a specified period in exchange for money or other considerations.

**Management** - The process of implementing goals and objectives using active and passive techniques.

**Management Compartment** - A subdivision of a forest property with easily defined boundaries such as rivers, lakes, and roads. Compartments are established for forest management purposes, most notably forest reconnaissance. They may vary in size from a hundred acres to more than a thousand.

**Marsh** - A wetland usually characterized by grasses or cattails.

**National Hierarchical Framework of Ecological Units** - The National Hierarchical Framework of Ecological Units (NHFEU) is a hierarchical ecological land classification system. Ecological units are identified and differentiated based on unique combinations of physical and biological characteristics, which may include climate, geology, geomorphology, soils, hydrology, or potential natural vegetation.

**Native** - Indigenous to the area or region.

**Old Growth** - The (usually) late successional stage of forest development.

**Over story** - That portion of the trees in a forest forming the uppermost canopy layer.

**Prescribed Burn** - To deliberately burn, wildland fuels in either their natural or their modified state and under specific environmental conditions, which allows the fire to be confined to a predetermined area and produces the fire line intensity and rate of spread required to attain planned resource management objectives.

**Regeneration Harvesting** - The removal of all trees at one time to create the conditions necessary for seedling establishment or sprouting (also referred to in the past as clear cutting).

**Selection Harvest** - A cutting procedure in which individual trees of all size classes are removed more or less uniformly throughout the stand, to promote growth of remaining trees and to provide space for regeneration.

**Shelterwood Harvest** - A cutting procedure by which a new age class is created. The cutting of most trees, leaving those needed to produce sufficient shade to produce a new age class in a moderated microenvironment.

**Silviculture** - The art and science of controlling the establishment, growth, composition, health, and quality of forests and woodlands to meet the diverse needs and values of landowners and society on a sustainable basis.

**Slash** - The residue, e.g. treetops and branches, left on the ground after logging or accumulating because of storm, fire girdling, or delimbing.

**Snag** - Any standing dead tree or portion thereof.

**Sustainable** - The yield of a natural resource that can be produced continually at a given intensity of management is said to be sustainable.

**Sustainable Forest Management** - The practice of meeting the forest resource needs and values of the present without compromising the similar capability of future generations.

**TSl** (**Timber Stand Improvement**) - I) An intermediate treatment made to improve stand composition, structure, condition, health and growth. 2) Non-commercial intermediate treatments.

**Understory** - All forest vegetation growing under an overstory.

**Wetland** - an area where water is at, near, or above the land surface long enough to be capable of supporting aquatic or hydrophytic vegetation, and which has soil indicative of wet conditions.
